Nancy Hartman continues to work tirelessly on our newsletter and internet presence. Bruce Appleby is working diligently to represent our concerns on the State SUAA board. Thanks to all who contribute to this organization's mission.

## SIUC Spring General Membership meeting held on April 29

The Spring General Membership meeting was held on April 29, 2011 at the Dunn-Richmond Center with approximately 60 members attending. President Bob Radtke opened the meeting by welcoming and thanking those who attended. The agenda included the announcement of four scholarship winners by Scholarship Chair, Imogene Beckemeyer. See article on page 3 for additional details about the four recipients of our \$1000 awards for 2011-12.

The election of new officers and board members for the year beginning, July 1, 2011, was also conducted. Those elected to office were: John Pohlmann, President; Bruce Appleby, Vice President; Pansy Jones, Secretary; Don Stucky, Treasurer. Bill Wright was elected to the Broad, representing the faculty emeritus sector. Other board members who are continuing their terms are: Doug Bedient, Mike Hanes, Nancy Hartman, Thyra Russell, JP Dunn, and Bob Radtke, Immediate Past President. Retiring board members were Carol Burns and Carolyn Donow.

SIUC Chancellor Rita Cheng was the meeting's featured speaker. She addressed the group for approximately 30 minutes and gave an overview of her goals for the campus. The membership enjoyed a luncheon in the Atrium following the meeting.

## Current Status of Healthcare Contracts

On August 23, Central Management Services (CMS) provided the following information regarding the current status of the healthcare contracts with the State of Illinois.

The Commission on Government Forecasting and Accountability (COGFA) held a hearing on August 16, 2011, to consider a request by the State to continue to offer self-insured managed care plans. At the end of that hearing, COGFA voted to authorize the State to continue to offer the self-insured managed care plans through June 30, 2012.

Based on that decision, the Department of Healthcare and Family Services is in the process of negotiating with both the self-insured managed care plans (HealthLink OAP, PersonalCare OAP and Health Alliance Illinois) and the fully-insured managed care plans (Health Alliance HMO and PersonalCare HMO) on extensions of the current contracts.

The next step is a hearing before the Executive Ethics Commission (EEC). That hearing is scheduled for August 31, 2011 at 1 p.m. The EEC has the final authority to approve these contract extensions.

These hearings have no impact on the current contracts with CIGNA and Blue Cross/Blue Shield (HMO Illinois and BlueAdvantage HMO). Those contracts remain in place.

**SPECIAL ENROLLMENT PERIOD.** If the contract with any vendor is NOT extended, the CM Group Insurance Division will hold a Special Enrollment Period in September for the affected members of that plan(s) only. Those elections would be effective September 29th.

A second Special Enrollment Period will be held for all members later in the fall. Alternatively, if all current contracts are extended, a Special Enrollment Period will be held for all members later in the fall.

**WHAT DO MEMBERS NEED TO DO?** For now, the important thing to realize is that nothing has changed. Members remain enrolled in and covered by their current health carrier.

The four \$1000 awards are going to the following exceptional SIUC students for the 2011-12 academic year.

**Caitlin A. Moliske**, physiology major, plans to earn PhD and M.D. degrees with a molecular physiology concentration and hopes to do medical research and be a pediatrician, perhaps at St. Jude's Research Hospital. At SIUC, she has been assistant director and executive director of SIUC Leadership conference; assistant director and sponsorship chair for Up 'til Dawn for St. Jude; has done undergraduate research; is an alum of Research Rookies; was intercommunication chair for Student Researchers in Physiology and Anatomy; was service chair of Saluki Science Ambassadors; and, has worked in a pharmacy as a licensed pharmacy technologist.

In 2011, she received a Provost Scholarship Award and the Tommy Yau Memorial Scholarship for the Outstanding Junior.

**Jessica M. Stout**, physiology major, chemistry and psychology minors, plans to attend medical school to prepare for a career in pediatric oncology, hopefully at St. Jude's Children's Research Hospital. At SIUC, she has been executive director of Up 'til Dawn—a fund raiser for St. Jude's; team captain for Student Life Advisers; A Saluki Science

Ambassador; community service chairperson of Scholars United Making Major Impacts a Tradition; a summer camp counselor for children fighting cancer; secretary of Student Researchers in Physiology and Anatomy; organizer for a trip to Memphis with other students to visit St. Jude's. She was to present findings from research at a 2011 Experimental Biology meeting in Washington, D.C. She received a 2011 Presidential Scholar Award.

**Laura F. Wolf**, English and animal science majors, has goals of training horses in her own facility and teaching high school English. She has been the primary trainer for several off-track thoroughbreds. She saved her money and bought a horse that was underweight and covered from humans; she was able to help restore him to health and gain his friendship. At SIUC, she is vice president of the Equestrian Team; a member of Alpha Zeta honor fraternity; Saluki volunteer Corps, Honors Program, Student Leadership Council, and Recreational Belly dance. We were told she helps to care for all horses at the SIUC barn, not just her own. She placed with the top four riders of her class. At a show in Kansas, the hunt captain was injured and Laura filled in as leader on a moment's notice. She has helped to organize the SIUC horse show.

Her latest update spotlights **Emily Toennies**, Breese Mater Dei High School graduate, who was selected for a 2009-10 SUAA scholarship. Emily won the Emerson Excellence Award that is a post-graduate scholarship given annually to one female and male Missouri Valley Conference athlete due to their exemplary academic and athletic performances. Toennies and Illinois State's Scott Krapf will each receive a \$10,000 postgraduate scholarship.

Toennies was a four-year letter winner in track and cross country. She graduated in the spring of 2011 with a 4.0 GPA in biological sciences and minor in chemistry. She was named to the MVC's scholar-athlete team three times in track and field and twice in cross country. She earned the MVC's Elite 18 award, which is given to the Valley athlete with the highest cumulative GPA competing at each of the conference's 18 championships. She won in both cross country and indoor track and field and was the only athlete to take the award in two sports.

A four-time All-MVC selection, Toennies ranks in the top 10 in school history in seven track and field events and is the school record holder in the indoor 5,000-meter run. Toennies plans to pursue a doctorate in physical therapy at Washington University in St. Louis. Congratulations, Emily!

## Appleby re-elected to SUAA Executive Committee

Bruce C. Appleby, vice-president/president-elect of the SIUC EAA, was re-elected to the executive committee of SUAA during the June meeting of the board of directors of SUAA in Springfield, June 21 and 22. This is his second two-year term on the SUAA executive committee.

The State Universities Annuitants Association Annual meeting was held in Springfield on June 21 and 22. Representing the SIUC EAA chapter were Bob Radtke and Bruce Appleby. The theme of the meeting was **FIGHTING BACK**

Even with the recent 2% income tax increase, there is still a large state budget deficit to overcome. There is no agreement to borrow more money, no agreement to tax more, and there is no agreement to make more budget cuts. Things seem to be at a stalemate. However, state pension reform and changes to health insurance benefits seem to be at the forefront of the discussion. SUAA continues the fight to protect our hard-earned benefits.

There was considerable discussion regarding Senate Bill 512, which would change pension benefits and costs for current employees. It should be noted that SUAA led a very effective campaign against this bill so that it never came to a vote in the House or the Senate. However, the bill is not dead and will likely come up again in either the fall veto session or next year. The bill would require participants who earned service prior to Jan. 1, 2011 (Tier 1 participants) to elect one of the following benefit formulas: Option I is the traditional Tier 1 package but at significantly higher employee contributions. The cost for the first 3 years would be 15.3% of pay (instead of the current 8%) and would be reevaluated every 3 years thereafter. Option II is the revised benefit package (Tier 2) in place for all those hired after January 1, 2011. Option III is the self-managed plan. A well-researched and well-reasoned presentation by Eric Madiar concluded that changing the contract of current employees as mandated by SB 512 is patently unconstitutional. Others obviously disagree. If such a bill is passed, it will undoubtedly end up in the courts.

Health care premiums are still under discussion, although there was very little information forthcoming about this issue. Recent decisions have extended the contracts of Health Alliance and Humana until the end of the year. Be assured that this issue will continue to resurface and that SUAA will continue to monitor legislative deliberations and equitable and fair treatment of SURS retirees, especially those who are not Medicare eligible.

There was a panel discussion about retiree pension and health care issues on which our own David Yepsen, of the Paul Simon Public Policy Institute, was a member. The general consensus of that panel was that, given the severe financial problems faced by the state, retirees are going to have to give some. It is not going to be good enough to say that we paid our share and that the state government has reneged on its commitments in the past; therefore, you owe us. The fact is that the state can't pay, and that we, the retirees are going to have to be part of the solution.

The SURS report by Bill Mabe, SURS Executive Director, discussed the fact that benefit recipients and benefit expenditures have increased faster than membership growth over the last few years. However, the system is still financially sound. He talked about the change in the money-purchase formula that is mandated to be reviewed at least every five years. The recent change, to go into effect on July 2, 2012, will result in an 8% reduction in the member's annuity as calculated by the money purchase formula, relative to the years of service formula. This change in money purchase formula calculations can be offset by delaying receipt of retirement benefits by 10 – 12 months.

The membership committee reported a current membership of 15,172. Our membership comprises only a small percentage of SURS retirees, all of whom we strive to represent. Although we added 1646 new members this year, there were 327 deceased and 930 non-renewals of membership, resulting in a net increase of only 389 members. There are approximately 2000 new SURS retirees every year. The push for membership this year will continue to be on currently employed SURS members, who will be impacted the most by any changes in the pension system, and on the large number of none-renewal memberships.

In the last issue of our newsletter, we featured the installation of Dr. Rita Cheng as the twenty-second Chancellor of SIUC. In this issue, we are featuring one of her first major campus initiatives that is focused on revamping the campus image, that was rolled out recently. The initiative revolves around what is being touted as ‘rebranding’ the Carbondale campus in an effort to change perceptions by focusing on its strengths in hopes of increasing enrollment, among other things.

One of the most visible changes that comes with the new initiative is the development of a new logo for the campus, which Chancellor Cheng unveiled just prior to the beginning of the Fall semester, that provided a fresh new atmosphere to welcome incoming students and their parents to campus. The new logo replaces the Pulliam Hall Clock Tower and features a simplified

SIU with maroon and white lettering and the word Carbondale underneath it.

The outside Chicago-based firm of Lipman Hearne was hired to develop new branding and marketing techniques that will place emphasis on the university’s strong academic and research programs in order to get the message out to recruit and retain high achieving students.

In an article that appeared on the August 14, 2011, *Saluki Times* website (<http://news.siu.edu/>), it was reported that other initiatives under way include:

- Strengthening SIU’s partnerships with the area’s community colleges to increase the number of students who transfer to SIU to complete a four-year degree;
- Transforming math and English courses for greater student learning and success;
- Examining all degree programs to ensure that full-time students who do not change majors can complete their coursework in four years at or near the 120 credit requirement; and
- Enhancing student success through University College, which will centralize and coordinate all services to support new freshmen and transfer students and improve their campus experience.

OTHER SIUC LOGOS THAT HAVE JOINED THE RANKS OF ‘RETIRED.’

The current change in logos is not something new to the Carbondale campus. No doubt, many of our members can recall the numerous times the logo has changed over the years. Some logos seemed to have lasted longer than others, while others seemed to have been very short lived and have vanished almost overnight.

In a trip down memory lane, the SINU Logo to the left was used to designate the campus in years prior to 1948 when the campus was known as Southern Illinois Normal University, based on a picture of a float with a banner that read, “We A’int Normal No More.” that was in the 1948 homecoming parade. Another past logo, referred to as the

Pyramid Logo, shown on the upper right, reflects an Egyptian theme using triangle shapes to symbolize the Pyramids and incorporates the Saluki dog, which became the university’s mascot after the campus became known as Southern Illinois University in 1947. A library search did not return any results on the years this logo was used, but current library staff can remember it being etched on frosted glass in the library prior to its recent renovations. A guess is the logo was used in the 1950 and early 1960s.

A more familiar image to many, and perhaps the one most identify with, is called the Dot Logo, and features the maroon dot, or circle, with the white SIU lettering in the center. This logo enjoyed a 30-year run from 1968 - 1998. The Sunrise Dot logo followed with a fairly short lived run from 1998 - 2005, when it was replaced in 2006 by the more recent Pulliam Clock Tower logo shown above.

So whichever logo you most identify with, the campus is about to embrace a new one to symbolize all the best of SIUC.

Your local chapter of SUAA, the SIUC Emeritus and Annuitant Association (EAA), is encouraging you to assist in increasing the number of SIUC retirees and current employees who are members of SUAA. SUAA surpassed its overall goal of 700 new members for the year. The focus for 2011/2012 is on retention.

Presently, our EAA chapter has 718 members. Our goal for the coming year is to gain 35 new members and increase retention by 35%. We need assistance from **ALL MEMBERS**. Dues are \$31 per year, of which \$6 is used for local chapter activities – including membership meetings, social events, a newsletter, a lecture series, a scholarship fund, and much more.

  3. Introducing legislation to improve benefits for all participants and beneficiaries of SURS.
  4. Opposing legislation to impose a premium for healthcare coverage on retirees.

- By working with two lobbyists at the Capitol on SUAA legislative issues.
