The SIUC Annuitants Association is proud to announce the four recipients of its scholarship program for the 2012-13 academic year. Awards of \$1,000 each were awarded in April to Lucas Cherry, Lindsay Dubois, Samuel Martin, and Taylor Wilson. Each of the four is listed in the 2012 Spring Honors Day program with a 3.9 or higher GPA and each received one or more other scholarships. Taylor Wilson will be a junior, while the other three will be seniors.

Lucas Cherry, an accounting major, is a three year member of the SIUC Track and Field/Cross Country team and belongs to the Fellowship of Christians Athletes as well as serving as a camp counselor; is vice president of the Business Leadership council; and has made eight mission trips to five countries. His goal is to attain a Master's degree and CPA and he plans to work in international business with a non-profit.

Lindsay Dubois, is an Early Childhood major with a Pre-school primary emphasis. Her extra curricular activities include: vice-president of the Educ8kdz and Gymnastics Club; is an undergraduate recruiter for SUMMIT; belongs to Minorities in Computer Science, Research Rookies, Saluki Scholars Research Opportunity, and is a student employee at WSIU, where she helps train WSIU volunteers. 

Greetings!

There's good news and bad news from Springfield. The good news: the State made a full annual contribution to SURS for Fiscal Year 2013. Public Act 97-0685 appropriated \$1.4 billion for the State's required annual contribution to SURS. The bad news: Public Act 97-0695 requires CMS to determine annuitant premiums for State provided health insurance. CMS is mandated to consider 1. pension income, 2. years of service and 3. Medicare participation in setting premiums. We will be watching the news anxiously on this and other matters that affect us. Check out Bruce Appleby's column in this newsletter for more information about recent legislative session.

Retirements at SIUC have more than doubled this year. The primary reason for this increase is the actuarial recalculation of the money purchase pension formula. If you know someone who recently retired from SIUC please invite them to join the Annuitants Association and attend our next meeting.

Our area legislators will join us at our next general meeting to discuss recent and proposed legislation affecting SURS annuitants. Some of the legislators have already accepted our invitation. So, the meeting should be informative and provide you an opportunity to interact with your legislators.

Our general meeting is scheduled for Friday, September 28th at 10:00 am at the Student Center, Ballroom B. There will be a brief business meeting before our guest speakers begin. The Emeritus Faculty Organization will meet at 8:30 am. I hope you will join us.

AN EVENING WITH LINDA BROOKHART, SUAA EXECUTIVE DIRECTOR

On May 7, 2012, the SIUC Annuitant Association Chapter sponsored an open meeting for all SIUC faculty, staff, and administrators with SUAA Executive Director Linda Brookhart. The purpose of the meeting was to introduce Linda to the campus community and to provide a forum to discuss with the SIUC community the implications of state pension and benefit legislation that impacts SURS members -- primarily current employees as well as retirees. The meeting was planned by the Chapter's membership committee with a focus on promoting the organization to current employees and to increase membership.

The evening meeting was held in Ballroom B at the Student Center and was attended by approximately 200 SURS members. Bruce Appleby, chapter Vice President, indicated that, "I was pleased with the turnout, but not as pleased that we didn't meet our goal of getting people to join SUAA. I think the membership for our chapter went up by only 7 or 8 after the meeting with Linda. That aside, it was a good chance for people to hear what SUAA does and to get information on what is happening to our pensions and benefits in Springfield. I can only hope that those who attended are now paying more attention to the issues as they come out of Springfield and will put forth effort to defeat CA 49 when they vote in November."

The Board of Directors of SUAA met in Springfield on June 19 and 20, 2012. A wide range of speakers gave presentations on a wide range of topics of interest to retirees and those who will be retiring.

At the opening day luncheon, Ralph Martire of the Center for Tax and Budget Accountability gave a talk on "The State of Illinois Budget and a Look at a Progressive Income Tax for Illinois." Martire is of the opinion that it is only through a progressive income tax that Illinois can solve its money problems. Since changing the income tax to a progressive table rather than a flat rate involves a change in the state constitution and since this is an election year, Martire doubts that this will happen this year.

A most interesting panel was made up of lobbyists, all of whom are former Speakers of the Third House (the third house is the loosely organized group of lobbyists in Springfield). They spoke about how the General Assembly operates and why it is so difficult to get changes made, especially (once again) in an election year.

William Mabe, Executive Director of the State Universities Retirement System, gave a presentation on how the benefit expenses for SURS retirees has grown and how the retirement picture has changed in Illinois. SIUC has seen a huge growth in the number of retirees this year and that is just a part of a state wide trend. In 2002, approximately 2,250 people retired from the state's universities and community colleges. In 2012, over 4,500 have retired. Among the reasons for this increase in the number retiring are the money purchase factor changes, the potential pension legislation in the General Assembly, and people meeting the age and/or service requirements.

Mabe also spoke about the various bills that have been in the legislature that are of direct interest to SUAA members. Senate Bill 2348 appropriated the full fiscal year 2013 certified contribution to SURS, which comes to \$1,402,800,000. Senate Bill 1313, which passed both houses, provides that Central Management Services shall determine the state's contribution to health insurance for retirees, removing the current formula (5% premium reimbursement per year of service up to a maximum of 100%) Senate Bill 1673, a bill of comprehensive pension reform, was not passed by the General Assembly, and was not taken up in the so-called "Pension Reform Session" that took place on August 17, 2012. This is the bill that would force employees and retirees to chose between receiving the COLA (cost of living adjustment) OR having their health insurance paid for by the state. This bill is also the one that would make the universities and community colleges responsible for paying an increased share of the annual costs of pensions.

Malcolm Weems, Director of Central Management Service (CMS), and Janice Bonneville, Senior Public Service Administrator of CMS, gave a presentation on Senate Bill 1313 and how CMS is progressing on implementing the bill. At the time of the presentation (June 19), CMS has yet to determine exactly what will happen to our health benefits and how we may have to pay for them.

Special Feature - Constitutional Amendment CA 49

Upcoming legislation pending in Springfield can have dire consequences on our current pension system (SURS) and on state university employee/retiree benefits. Three different pieces of legislation, that have either passed, or are on the docket, pose changes to our current pension and benefits that could impact current employees and retirees in not only their pensions, but also the annual cost of living increases and the health insurance benefits that have been guaranteed to this group by fulfilling their contractual obligation with the state of Illinois and university.

These issues are complicated and those of us affected cannot sit back and be complacent and expect it to all work out in our best interest. ***We are under attack***, like never before, by a majority of powerful legislators who control the way things roll in Springfield and by an uninformed and unsympathetic private sector. This should get your attention and your support in helping to defray further erosion of what we have paid for and earned. For these reasons, we are focusing on the importance of your need to understand the issues that the people of Illinois will be voting on in November and how it can affect our pension system and annuities.

Reasons to VOTE on Constitutional Amendment 49

(This article was written by Bruce C. Appleby, a member of the SUAA CA 49 Committee and of the executive committee of SUAA. Both groups helped develop the talking points at the end. Bruce has used the conversations and emails of the two committees to develop the article and is solely responsible for its content.)

The following chart illustrates the impact the proposed Constitution Amendment (CA 49) can have on our current system. Following the chart is a discussion of the other two pieces of legislation that will also have a direct impact on our system and benefits.

<u>CURRENT LAW</u>	<u>Constitutional Amendment (CA) 49</u>	<u>Implications on our current pensions and benefits</u>
Article XIII, Section 5 of the Illinois State Constitution (the constitutional article where our pensions and benefits are guaranteed), states:	Constitutional Amendment (CA) 49 is an addition to Article XIII, Section 5 and becomes Article XIII, Section 5.1. It thus appears to limit Article XIII, Section 5 and to take precedence.	
Membership in any pension or retirement system of the State, any unit of local government or school district, or any agency or instrumentality thereof, shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired.	Clause 1 of CA 49 states: No bill, except a bill for appropriation, that provides a benefit increase under any pension or retirement system of the State, any unit or local government or school district or any agency thereof, shall become law without the concurrence of three-fifths of the members of the General Assembly.	If CA 49 passes, we could, down the road, possibly lose the constitutional protection we have of our current pensions and benefits.
	Clause 2 of CA 49 states: Nothing in this Section shall prevent the passage or adoption of any law, ordinance, resolution, rule, policy, or practice that further restricts the ability to provide a "benefit increase," emolument increase," or "beneficial determination" as those terms are used under this Section.	CA 49 creates a loophole for the General Assembly, leaving the possibility that the General Assembly could take away a benefit from state employees and retirees (under Clause 2) and could possibly take any action at any time and in any way that would restrict our pension and benefits, including our COLA.

Wading through the language that seems to purposely mislead and misdirect, it appears that Clause 1 says that a 60% majority of both houses is needed to increase any pension benefit of any unit of government in the state. Clause 2 appears to say that the General Assembly may take any action that restricts benefit increases, which would include the COLA (cost of living adjustment) or any other aspect of our pensions and benefits—at any time and in any way.

How will all this play with the passage of Senate Bill 1313 (the bill passed by both houses of the General Assembly which says university employees now have to pay for our health benefits) and with the potential passage of Senate Bill 1673 (which would force you to choose between an annual COLA increase or having to pay for your health coverage) is anyone's guess. Thousands of pages of paper and miles of emails have expressed opinions on CA 49 and these two bills. Until they are tested in the courts, we can't be sure exactly what will happen to our pensions and benefits.

For now, we have to concentrate on and put forth herculean effort to defeat CA 49. All members of all retirement systems (State University Retirement System, Teacher Retirement System, State Employee Retirement System, Judicial Retirement System and General Assembly Retirement System) will be affected by this. There are currently a number of suits that have been brought against the General Assembly and the Central Management System trying to stop the above bills and CA 49. There are more than 196,000 retirees in these systems and each of them, plus all their family members and friends, should vote NO on CA 49. More importantly, all current employees working in these systems, especially the tier 2 members and new hires, will be much more directly affected by CA 49 than will those of us already retired.

Talk to your family and all your friends. Let everyone you know that CA 49 must be defeated for your sake and for that of 1,000's of Illinois residents. Use the following points as you convince others to vote with you and DEFEAT CA 49.

Talking Points for: VOTING ON CA 49

Constitutional Amendment 49 is the most dangerous threat ever to face public employees and retirees in Illinois. Here's why:

- CA 49 is ambiguous, confusing, difficult to understand and complex. What does it really mean?
- CA 49 is the latest in a series of attacks on you and other public employees and retirees.
- CA 49 would grant unprecedented power to state and local governments to make changes to pension benefits and existing law.

If CA 49 passes on November 6, 2012, here's what will happen:

- CA 49 will allow the MINORITY vote—not the majority—to determine benefit decisions at every level of government in the state.
- CA 49 will NOT result in saving to taxpayers.
- CA 49 will do NOTHING to address the State's financial crisis.
- CA 49 will scare away public employees, affecting future hiring and retention.
- CA 49 impairs the future viability of all Illinois public education and public services.
